Canterbury City Council mutual exchange application form

- Both parties must complete a separate application form
- By law we must tell you our decision within 42 calendar days of receiving application forms from you and the person you are looking to exchange with. Please bear this in mind when planning your moving date
- All applications for mutual exchanges will be considered unless
 - the property is much too small or too big for the incoming tenant, or
 - if it is specially adapted for the elderly or disabled
- If your request to exchange is agreed you must accept your new home 'as seen'. Canterbury City Council will only carry out repairs for which it is legally responsible. We will not carry out any decorations or undertake any work arising from a tenant's neglect or damage
- If you have any rent arrears, or any other outstanding housing debts to Canterbury City Council, these must be paid before the exchange can take place
- You must not exchange properties, or make any removal arrangements, until you have our written permission for the exchange to go ahead
- As a result of the exchange your terms and condition of tenancy and rights may change. You should therefore check this before agreeing to exchange
- You will be required to provide some proof of identification when you sign for your new tenancy.
